- **DESCENDER:** THE PORTION OF A LETTER THAT DIPS BELOW THE BASELINE, VISIBLE IN LETTERS SUCH AS "g," "j," AND "p."
- **SERIF:** SMALL LINES OR DECORATIONS ADDED TO THE ENDS OF A LETTER'S MAIN STROKES, WHICH CAN SIGNIFICANTLY AFFECT THE OVERALL FEEL OF A TYPEFACE.
- **COUNTER:** THE ENCLOSED OR PARTIALLY ENCLOSED SPACE WITHIN A LETTER, SUCH AS THE INNER AREA OF "o" OR "p."
- **STROKE:** THE MAIN DIAGONAL OR VERTICAL LINES THAT MAKE UP EACH LETTERFORM.
- **WEIGHT:** THIS REFERS TO THE THICKNESS OF THE CHARACTER'S STROKES, WHICH CAN RANGE FROM LIGHT TO BOLD.

UNDERSTANDING THESE COMPONENTS IS ESSENTIAL FOR ANYONE INVOLVED IN TYPOGRAPHY, AS THEY DIRECTLY INFLUENCE A TYPEFACE'S AESTHETICS AND READABILITY. DESIGNERS OFTEN ANALYZE THESE ELEMENTS TO ENSURE THAT THEIR CHOSEN FONTS ALIGN WITH THE INTENDED MESSAGE AND AUDIENCE.
