TYPES OF CRIMES AGAINST ANATOMY SOD

ASSAULT AND BATTERY

ASSAULT AND BATTERY ARE AMONG THE MOST COMMON TYPES OF CRIMES AGAINST ANATOMY SOD. ASSAULT TYPICALLY INVOLVES THE THREAT OF VIOLENCE OR AN ATTEMPT TO CAUSE PHYSICAL HARM, WHILE BATTERY REFERS TO THE ACTUAL PHYSICAL CONTACT OR HARM INFLICTED ON ANOTHER PERSON.

- SIMPLE ASSAULT: INVOLVES MINOR INJURIES OR THREATS WITHOUT PHYSICAL CONTACT.

- AGGRAVATED ASSAULT: INVOLVES SERIOUS INJURIES OR THE USE OF WEAPONS.
- SIMPLE BATTERY: INVOLVES MINOR PHYSICAL HARM OR OFFENSIVE TOUCHING.
- AGGRAVATED BATTERY: INVOLVES SEVERE INJURIES OR THE USE OF DEADLY FORCE.

MUTILATION AND DISFIGUREMENT

MUTILATION REFERS TO THE INTENTIONAL INFLECTION OF SEVERE BODILY HARM THAT RESULTS IN PERMANENT DAMAGE OR DISFIGUREMENT. THIS CRIME IS PARTICULARLY HEINOUS AS IT NOT ONLY CAUSES PHYSICAL PAIN BUT ALSO LEAVES LASTING EMOTIONAL SCARS ON VICTIMS.
