UNDERSTANDING THE THREE BRANCHES OF GOVERNMENT

THE EXECUTIVE BRANCH

THE EXECUTIVE BRANCH IS HEADED BY THE PRESIDENT OF THE UNITED STATES, WHO IS RESPONSIBLE FOR ENFORCING LAWS AND MANAGING THE FEDERAL GOVERNMENT. THIS BRANCH INCLUDES THE VICE PRESIDENT, THE PRESIDENT'S CABINET, AND VARIOUS FEDERAL AGENCIES. KEY RESPONSIBILITIES OF THE EXECUTIVE BRANCH INCLUDE:

- ENFORCING FEDERAL LAWS AND IMPLEMENTING POLICY.

- VETOING LEGISLATION PASSED BY CONGRESS.

THE JUDICIAL BRANCH

THE JUDICIAL BRANCH INTERPRETS LAWS AND ENSURES THEY ARE APPLIED FAIRLY. IT IS COMPRISED OF THE SUPREME COURT AND OTHER FEDERAL COURTS. THE PRIMARY FUNCTIONS OF THE JUDICIAL BRANCH ARE:

- INTERPRETING THE CONSTITUTION AND FEDERAL LAWS.
- RESOLVING DISPUTES INVOLVING STATES OR BETWEEN CITIZENS.
- REVIEWING THE CONSTITUTIONALITY OF LAWS AND EXECUTIVE ACTIONS.
- PROVIDING CHECKS ON THE POWERS OF THE OTHER BRANCHES.

FUNCTIONS OF EACH BRANCH

JUDICIAL POWERS

THE JUDICIAL BRANCH PLAYS A CRITICAL ROLE IN INTERPRETING LAWS AND ENSURING JUSTICE. ITS POWERS INCLUDE:

- DECIDING CASES THAT INVOLVE FEDERAL LAW OR CONSTITUTIONAL ISSUES.
- DETERMINING THE LEGALITY OF EXECUTIVE ACTIONS.

- CONFIRMING OR REJECTING PRESIDENTIAL APPOINTMENTS.
- IMPEACHING THE PRESIDENT FOR MISCONDUCT.

EXECUTIVE CHECKS ON THE LEGISLATIVE

THE EXECUTIVE BRANCH CAN CHECK THE LEGISLATIVE BRANCH BY:

- VETOING LEGISLATION THAT IT DEEMS UNFIT.
- CALLING SPECIAL SESSIONS OF CONGRESS.
- INFLUENCING PUBLIC OPINION TO SWAY LEGISLATIVE DECISIONS.

JUDICIAL CHECKS ON BOTH BRANCHES

THE JUDICIAL BRANCH CHECKS BOTH THE LEGISLATIVE AND EXECUTIVE BRANCHES BY:

- DECLARING LAWS UNCONSTITUTIONAL, THEREBY NULLIFYING THEM.
- REVIEWING EXECUTIVE ACTIONS TO ENSURE COMPLIANCE WITH THE CONSTITUTION.
- INTERPRETING LAWS AND RESOLVING DISPUTES BETWEEN BRANCHES.
