DETERMINE THE COSTS

SET A TIMELINE

ADJUST THESE PERCENTAGES BASED ON YOUR PRIORITIES AND FINANCIAL GOALS. THE KEY IS TO ENSURE THAT YOU ARE CONSISTENTLY SAVING A PORTION OF YOUR INCOME.
