- **ANARCHY:** THE ABSENCE OF GOVERNMENT AND ABSOLUTE FREEDOM FOR INDIVIDUALS, OFTEN RESULTING IN A STATE OF DISORDER.

THOMAS HOBBS

HOBBS VIEWED THE SOCIAL CONTRACT AS A NECESSITY TO ESCAPE THE CHAOS OF A STATE OF NATURE, WHERE LIFE WITHOUT GOVERNMENT WAS "SOLITARY, POOR, NASTY, BRUTISH, AND SHORT." HE ARGUED FOR A POWERFUL SOVEREIGN TO MAINTAIN PEACE AND ORDER.

JOHN LOCKE

LOCKE HAD A MORE OPTIMISTIC VIEW, POSITING THAT PEOPLE ARE INHERENTLY REASONABLE AND CAPABLE OF SELF-GOVERNANCE. HE BELIEVED THAT THE SOCIAL CONTRACT EXISTS TO PROTECT NATURAL RIGHTS—LIFE, LIBERTY, AND PROPERTY—AND THAT GOVERNMENT SHOULD BE ACCOUNTABLE TO THE PEOPLE.

JEAN-JACQUES ROUSSEAU

ROUSSEAU EMPHASIZED THE COLLECTIVE WILL OF THE PEOPLE, ARGUING THAT TRUE FREEDOM IS ACHIEVED WHEN INDIVIDUALS ACT IN ACCORDANCE WITH THE GENERAL WILL. HE BELIEVED IN DIRECT DEMOCRACY AND THE IMPORTANCE OF CIVIC VIRTUE.
