BACKGROUND EXTINCTION DEFINITION BIOLOGY REFERS TO THE GRADUAL PROCESS OF SPECIES DISAPPEARING AT A RELATIVELY LOW RATE, WHICH IS A NATURAL ASPECT OF EVOLUTION AND ECOLOGICAL DYNAMICS. DEFINITION OF BACKGROUND EXTINCTION

UNDERSTANDING BACKGROUND EXTINCTION

BACKGROUND EXTINCTION IS DEFINED AS THE NORMAL RATE AT WHICH SPECIES BECOME EXTINCT OVER TIME, EXCLUDING THE MORE SIGNIFICANT SPIKES IN EXTINCTION RATES ASSOCIATED WITH MASS EXTINCTION EVENTS. TYPICALLY, BACKGROUND EXTINCTION RATES ARE ESTIMATED TO BE ABOUT 1 TO 5 SPECIES PER MILLION SPECIES PER YEAR. THIS PROCESS IS A NATURAL OCCURRENCE DRIVEN BY VARIOUS ECOLOGICAL AND EVOLUTIONARY FACTORS.

CHARACTERISTICS OF BACKGROUND EXTINCTION

THE CHARACTERISTICS OF BACKGROUND EXTINCTION INCLUDE:

- **SLOW AND GRADUAL:** UNLIKE MASS EXTINCTIONS, WHICH HAPPEN RAPIDLY AND AFFECT A LARGE NUMBER OF SPECIES ACROSS VARIOUS TAXA, BACKGROUND EXTINCTIONS OCCUR SLOWLY OVER GEOLOGICAL TIME SCALES.
- **SPECIES-SPECIFIC:** BACKGROUND EXTINCTION AFFECTS DIFFERENT SPECIES AT DIFFERENT RATES, OFTEN INFLUENCED BY THEIR ECOLOGICAL NICHES, REPRODUCTIVE RATES, AND ADAPTABILITY.
- **NATURAL SELECTION:** THIS PROCESS PLAYS A CRUCIAL ROLE IN BACKGROUND EXTINCTION, WHERE LESS ADAPTED SPECIES MAY GRADUALLY DISAPPEAR AS ENVIRONMENTAL CONDITIONS CHANGE.

SIGNIFICANCE OF BACKGROUND EXTINCTION IN BIOLOGY

BIODIVERSITY AND ECOSYSTEM HEALTH

NATURAL FACTORS

COMPARISON WITH MASS EXTINCTION EVENTS

DEFINING MASS EXTINCTION

KEY DIFFERENCES
