UNDERSTANDING LIVING ENVIRONMENT

THE TERM "LIVING ENVIRONMENT" REFERS TO THE VARIOUS SURROUNDINGS THAT AFFECT ORGANISMS' LIVES, INCLUDING THEIR HABITATS, COMMUNITIES, AND ECOSYSTEMS.
