INTRODUCTION TO BIOLOGICAL PRODUCTS

SECONDARY METABOLITES

THESE PRODUCTS ARE CRUCIAL FOR INTERACTIONS WITH OTHER ORGANISMS, INCLUDING PREDATORS AND POLLINATORS, AND PLAY ROLES IN DEFENSE AGAINST PATHOGENS.

SIGNIFICANCE OF BIOLOGICAL PRODUCTS

APPLICATIONS IN MEDICINE

APPLICATIONS IN AGRICULTURE
