THESE BUSINESS JETS ARE ESSENTIALLY ADAPTATIONS OF THE COMMERCIAL AIRLINER MODELS, DESIGNED TO OFFER LUXURY, COMFORT, AND THE ABILITY TO TRAVEL LONG DISTANCES WITHOUT COMPROMISING ON SPACE OR AMENITIES. THE BBJ RANGE INCLUDES MODELS DERIVED FROM THE 737, 747, 767, AND 787 FAMILIES, EACH OFFERING A UNIQUE COMBINATION OF FEATURES AND CAPABILITIES.

BBJs ARE KNOWN FOR THEIR SPACIOUS CABINS, WHICH CAN BE CONFIGURED TO INCLUDE BEDROOMS, CONFERENCE ROOMS, LOUNGES, AND EVEN DINING AREAS.
