COUNTY AND CITY RESOURCES

IN ADDITION TO THE STATE-LEVEL RESOURCES, LOCAL COUNTY AND CITY OFFICES ALSO MAINTAIN BUSINESS LICENSES AND PERMITS. EACH MUNICIPALITY MAY HAVE ITS OWN DATABASE WHERE RESIDENTS CAN LOOK UP BUSINESSES OPERATING WITHIN THEIR JURISDICTION. CHECKING WITH LOCAL CHAMBERS OF COMMERCE CAN ALSO YIELD VALUABLE INFORMATION ABOUT BUSINESSES IN SPECIFIC AREAS.

PRIVATE DATABASES AND PLATFORMS

SEVERAL PRIVATE PLATFORMS AGGREGATE BUSINESS INFORMATION FROM VARIOUS SOURCES. WEBSITES LIKE DUN & BRADSTREET, LINKEDIN, AND OTHERS OFFER DETAILED PROFILES ON COMPANIES, INCLUDING FINANCIALS, EMPLOYEE COUNTS, AND INDUSTRY CLASSIFICATIONS.
