- **Logo:** IF YOU HAVE A BUSINESS LOGO, INCORPORATE IT FOR BRAND RECOGNITION.

DESIGN TIPS FOR NOTARY BUSINESS CARDS

CHOOSE THE RIGHT COLOR SCHEME

UTILIZE WHITE SPACE

EFFECTIVE USE OF WHITE SPACE CAN MAKE YOUR CARD MORE APPEALING. AVOID OVERCROWDING YOUR BUSINESS CARD WITH INFORMATION. INSTEAD, FOCUS ON THE MOST CRITICAL DETAILS AND ALLOW FOR BREATHING ROOM AROUND EACH ELEMENT, WHICH ENHANCES READABILITY AND VISUAL APPEAL.

CONSIDER CARD SHAPE AND SIZE

WHILE STANDARD BUSINESS CARD SIZES ARE 3.5 x 2 INCHES, EXPERIMENTING WITH DIFFERENT SHAPES OR FINISHES CAN MAKE YOUR CARD STAND OUT. ROUNDED EDGES OR UNIQUE SHAPES CAN CREATE A MEMORABLE IMPRESSION. JUST BE SURE THAT THE CARD CAN STILL FIT INTO STANDARD BUSINESS CARD HOLDERS.
