YOU CAN FIND THE LIST ON THE U.S. CENSUS BUREAU WEBSITE OR THROUGH STATE RESOURCES. LOCATE THE SECTION THAT BEST MATCHES YOUR BUSINESS ACTIVITIES TO FIND YOUR PRINCIPAL BUSINESS ACTIVITY CODE.
