STEP 3: ENTER SEARCH CRITERIA

INPUT THE RELEVANT DETAILS INTO THE SEARCH FIELDS. FOR EXAMPLE, IF SEARCHING BY BUSINESS NAME, ENTER THE FULL NAME OR PARTIAL NAME OF THE ENTITY. ENSURE THAT SPELLING IS CORRECT TO AVOID ERRORS IN RESULTS.

STEP 4: REVIEW SEARCH RESULTS

TYPES OF INFORMATION AVAILABLE

ENTITY INFORMATION

FILING HISTORY

THE FILING HISTORY PROVIDES A CHRONOLOGICAL LIST OF DOCUMENTS FILED WITH THE SECRETARY OF STATE, INCLUDING FORMATION DOCUMENTS, AMENDMENTS, AND DISSOLUTION FILINGS. THIS HISTORY CAN BE CRITICAL FOR UNDERSTANDING THE BUSINESS'S OPERATIONAL TIMELINE.

OWNERSHIP INFORMATION

DETAILS ABOUT THE OWNERS, DIRECTORS, AND OFFICERS OF THE BUSINESS ARE OFTEN AVAILABLE. THIS INFORMATION CAN HELP IN ASSESSING THE INDIVIDUALS BEHIND A BUSINESS AND THEIR CREDIBILITY.

REGISTERED AGENT DETAILS

EVERY BUSINESS IN NEW YORK MUST HAVE A REGISTERED AGENT. THIS INFORMATION INCLUDES THE NAME AND ADDRESS OF THE AGENT, WHICH IS ESSENTIAL FOR LEGAL COMMUNICATIONS AND SERVICE OF PROCESS.

COMMON ISSUES AND TROUBLESHOOTING
