ELIGIBILITY AND APPLICATION PROCESS

THE APPLICATION PROCESS IS STRAIGHTFORWARD AND CAN BE COMPLETED ONLINE. APPLICANTS WILL NEED TO PROVIDE INFORMATION REGARDING THEIR BUSINESS, INCLUDING ITS LEGAL STRUCTURE, ANNUAL REVENUE, AND THE NUMBER OF EMPLOYEES. ONCE THE APPLICATION IS SUBMITTED, IT IS TYPICALLY REVIEWED WITHIN A FEW MINUTES, AND APPLICANTS ARE NOTIFIED OF THEIR APPROVAL STATUS SHORTLY THEREAFTER.
