1. STATE BUSINESS REGISTRATION WEBSITES

THESE STATE-SPECIFIC DATABASES ARE OFTEN THE FIRST STOP FOR ENTREPRENEURS. BY VISITING YOUR STATE'S SECRETARY OF STATE WEBSITE, YOU CAN ACCESS THEIR BUSINESS NAME SEARCH TOOL. HERE ARE SOME STEPS TO FOLLOW:

- VISIT THE SECRETARY OF STATE'S WEBSITE FOR YOUR STATE.

- INPUT YOUR DESIRED NAME TO SEE EXISTING TRADEMARKS.

3. ONLINE BUSINESS NAME CHECKERS

Q: DO I NEED A LAWYER TO HELP ME CHECK BUSINESS NAME AVAILABILITY?

A: WHILE YOU CAN CONDUCT A BUSINESS NAME SEARCH ON YOUR OWN, CONSULTING A LAWYER CAN BE BENEFICIAL, ESPECIALLY IF YOU PLAN TO TRADEMARK YOUR NAME OR IF YOU'RE UNSURE ABOUT THE LEGAL IMPLICATIONS OF YOUR CHOSEN NAME.

Q: HOW MUCH DOES IT COST TO REGISTER A BUSINESS NAME?

A: THE COST TO REGISTER A BUSINESS NAME VARIES BY STATE AND CAN RANGE FROM \$10 TO SEVERAL HUNDRED DOLLARS, DEPENDING ON THE TYPE OF BUSINESS ENTITY AND THE REGISTRATION METHOD. ADDITIONALLY, TRADEMARK REGISTRATION INVOLVES ADDITIONAL FEES.
