OXIDATION-REDUCTION REACTIONS

OXIDATION-REDUCTION (REDOX) REACTIONS ARE VITAL IN WATER TREATMENT FOR BREAKING DOWN HARMFUL SUBSTANCES. THESE REACTIONS INVOLVE THE TRANSFER OF ELECTRONS BETWEEN MOLECULES, LEADING TO THE CONVERSION OF CONTAMINANTS INTO LESS HARMFUL FORMS. FOR INSTANCE, OXIDIZING AGENTS LIKE CHLORINE AND OZONE ARE EMPLOYED TO ELIMINATE PATHOGENS AND DEGRADE ORGANIC POLLUTANTS.

PRECIPITATION

PRECIPITATION IS ANOTHER ESSENTIAL CHEMICAL PRINCIPLE IN WATER TREATMENT. IT INVOLVES THE FORMATION OF SOLID PARTICLES FROM DISSOLVED SUBSTANCES, WHICH CAN THEN BE REMOVED FROM THE WATER. FLOCCULATION IS THE GENTLE MIXING THAT ENCOURAGES THESE FLOCS TO GROW, MAKING THEM EASIER TO REMOVE DURING SEDIMENTATION.

SEDIMENTATION

AFTER COAGULATION AND FLOCCULATION, THE WATER IS ALLOWED TO SETTLE IN SEDIMENTATION BASINS. DURING THIS PROCESS, THE HEAVIER FLOCS SETTLE TO THE BOTTOM, FORMING SLUDGE, WHILE CLEARER WATER CAN BE DRAWN OFF THE TOP. THIS PROCESS SIGNIFICANTLY REDUCES THE CONCENTRATION OF SUSPENDED SOLIDS IN THE WATER.

FILTRATION

FOLLOWING SEDIMENTATION, FILTRATION IS EMPLOYED TO FURTHER PURIFY THE WATER. DIFFERENT FILTRATION METHODS, SUCH AS SAND FILTERS, ACTIVATED CARBON FILTERS, AND MEMBRANE FILTERS, ARE USED DEPENDING ON THE SPECIFIC CONTAMINANTS PRESENT. FILTRATION REMOVES REMAINING PARTICLES, BACTERIA, AND SOME CHEMICAL CONTAMINANTS, ENHANCING WATER QUALITY.

DISINFECTION

DISINFECTION IS A CRITICAL STEP IN WATER TREATMENT, AIMED AT ELIMINATING PATHOGENS THAT CAN CAUSE DISEASE. COMMON DISINFECTION METHODS INCLUDE CHLORINATION, ULTRAVIOLET (UV) LIGHT TREATMENT, AND OZONATION. EACH METHOD HAS ITS ADVANTAGES, WITH CHLORINE BEING WIDELY USED DUE TO ITS RESIDUAL EFFECT, WHICH CONTINUES TO DISINFECT WATER AS IT TRAVELS THROUGH DISTRIBUTION SYSTEMS.

CHEMICAL AGENTS USED IN WATER TREATMENT

COAGULANTS

- ALUMINUM SULFATE
- FERRIC CHLORIDE
- POLYMERIC COAGULANTS

THESE AGENTS WORK BY NEUTRALIZING THE CHARGE OF PARTICLES, ALLOWING THEM TO AGGREGATE AND SETTLE OUT OF THE WATER.

DISINFECTANTS

DISINFECTANTS ARE ESSENTIAL FOR KILLING HARMFUL MICROORGANISMS IN WATER. COMMON DISINFECTANTS INCLUDE:

- CHLORINE
- CHLORAMINES
- OZONE
- ULTRAVIOLET LIGHT

EACH DISINFECTANT HAS ITS MECHANISMS OF ACTION AND EFFECTIVENESS AGAINST DIFFERENT PATHOGENS, MAKING IT CRUCIAL TO SELECT THE APPROPRIATE ONE BASED ON SPECIFIC WATER TREATMENT NEEDS.

pH ADJUSTERS
