TYPES OF CHEMISTRY LAB HAZARDS

- **SPILL KITS:** APPROPRIATE SPILL KITS SHOULD BE AVAILABLE FOR CONTAINING AND CLEANING UP CHEMICAL SPILLS SAFELY.
- **FIRE EXTINGUISHERS:** FIRE EXTINGUISHERS TAILORED TO THE TYPES OF MATERIALS USED IN THE LAB SHOULD BE READILY AVAILABLE AND PERSONNEL TRAINED IN THEIR USE.

A: CHEMISTRY LABS SHOULD BE EQUIPPED WITH VARIOUS TYPES OF FIRE EXTINGUISHERS, INCLUDING CLASS A FOR ORDINARY COMBUSTIBLES, CLASS B FOR FLAMMABLE LIQUIDS, AND CLASS C FOR ELECTRICAL FIRES. PERSONNEL SHOULD BE TRAINED ON HOW TO USE THEM EFFECTIVELY.
