- **CARBONATES, PHOSPHATES, AND HYDROXIDES:** MOST CARBONATES (CO_3^{2-}), PHOSPHATES (PO_4^{3-}), AND HYDROXIDES (OH^-) ARE INSOLUBLE, EXCEPT FOR THOSE OF ALKALI METALS AND AMMONIUM.

THESE RULES PROVIDE A FOUNDATIONAL UNDERSTANDING OF SOLUBILITY IN AQUEOUS SOLUTIONS, ALLOWING CHEMISTS TO PREDICT THE BEHAVIOR OF VARIOUS COMPOUNDS IN DIFFERENT SETTINGS.

EXCEPTIONS TO THE SOLUBILITY RULES
