UNDERSTANDING THE BASICS

INTERACTIONS. FOR INSTANCE, THE KINETIC MOLECULAR THEORY OF GASES EXPLAINS THE BEHAVIOR OF GASES IN TERMS OF PARTICLE MOTION AND INTERACTIONS, OFFERING INSIGHTS INTO TEMPERATURE, PRESSURE, AND VOLUME RELATIONSHIPS. UNLIKE LAWS, THEORIES CAN EVOLVE OVER TIME AS NEW EVIDENCE EMERGES OR AS SCIENTISTS DEVELOP BETTER EXPLANATORY FRAMEWORKS.
