

MALLEABLE IN CHEMISTRY

DEFINITION OF MALLEABILITY

THIS PROPERTY IS A RESULT OF THE METALLIC BONDS FOUND IN METALS, WHICH ALLOW ATOMS TO SLIDE PAST ONE ANOTHER WHILE MAINTAINING OVERALL STRUCTURAL INTEGRITY.

THE MALLEABILITY OF A MATERIAL IS QUANTIFIED BY ITS CAPACITY TO BE SHAPED INTO VARIOUS FORMS. FOR INSTANCE, GOLD IS KNOWN FOR ITS EXCEPTIONAL MALLEABILITY, ALLOWING IT TO BE DRAWN INTO THIN SHEETS THAT ARE ONLY A FEW ATOMS THICK. MALLEABILITY VS. DUCTILITY

DIFFERENCES BETWEEN MALLEABILITY AND DUCTILITY

FACTORS AFFECTING MALLEABILITY

IMPURITIES

THE PRESENCE OF IMPURITIES IN A METAL CAN ADVERSELY AFFECT ITS MALLEABILITY. IMPURITIES CAN CREATE DEFECTS IN THE CRYSTAL LATTICE STRUCTURE OF THE METAL, MAKING IT MORE SUSCEPTIBLE TO BRITTLENESS. FOR INSTANCE, INTRODUCING CARBON INTO IRON PRODUCES STEEL, WHICH CAN EXHIBIT VARYING DEGREES OF MALLEABILITY BASED ON THE CARBON CONTENT. GENERALLY, HIGHER CARBON CONTENT RESULTS IN INCREASED HARDNESS BUT REDUCED MALLEABILITY.

METAL TYPE

DIFFERENT METALS EXHIBIT VARYING LEVELS OF MALLEABILITY DUE TO THEIR ATOMIC STRUCTURE. METALS WITH A FACE-CENTERED CUBIC (FCC) STRUCTURE, SUCH AS GOLD, SILVER, AND COPPER, TYPICALLY DISPLAY HIGH MALLEABILITY. IN CONTRAST, METALS WITH A BODY-CENTERED CUBIC (BCC) STRUCTURE, LIKE IRON, MAY HAVE LOWER MALLEABILITY DUE TO THEIR ATOMIC ARRANGEMENT, WHICH HINDERS MOVEMENT UNDER STRESS.

APPLICATIONS OF MALLEABLE MATERIALS
