- **EXPLOSIVE:** SHOWN WITH AN EXPLOSION GRAPHIC, THIS SYMBOL INDICATES THAT THE CHEMICAL CAN UNDERGO A VIOLENT REACTION, POSING A RISK OF EXPLOSION UNDER SPECIFIC CONDITIONS.
- **HEALTH HAZARD:** DEPICTED WITH A SILHOUETTE OF A PERSON WITH A STAR SYMBOL, THIS SYMBOL INDICATES THAT THE SUBSTANCE POSES A RISK TO HEALTH, SUCH AS CARCINOGENIC EFFECTS OR RESPIRATORY ISSUES.

THESE SYMBOLS ARE JUST A FEW EXAMPLES; MANY OTHERS EXIST THAT COMMUNICATE DIFFERENT HAZARDS. FAMILIARITY WITH THESE SYMBOLS IS VITAL FOR SAFE LABORATORY PRACTICES.

BEST PRACTICES FOR CHEMICAL SAFETY
