## FILTRATION

FILTRATION IS A CRITICAL STEP IN WATER TREATMENT, DESIGNED TO REMOVE REMAINING SOLIDS AND IMPURITIES FROM THE WATER. DIFFERENT FILTRATION METHODS INCLUDE:

- **SAND FILTRATION:** UTILIZES LAYERS OF SAND TO TRAP PARTICLES.
- **MEMBRANE FILTRATION:** EMPLOYS SEMI-PERMEABLE MEMBRANES TO SEPARATE CONTAMINANTS.

## DISINFECTION
