COMMON METHODS FOR CONFIRMATORY TESTING

IMMUNOASSAYS

IMMUNOASSAYS ARE HIGHLY SPECIFIC CONFIRMATORY TESTS USED PRIMARILY IN CLINICAL AND LABORATORY SETTINGS TO DETECT THE PRESENCE OF PROTEINS OR ANTIBODIES IN A SAMPLE. ENZYME-LINKED IMMUNOSORBENT ASSAY (ELISA) IS A COMMON EXAMPLE.

FUTURE TRENDS IN CONFIRMATORY TESTING
