- **NON-CURRENT ASSETS:** FOLLOWING CURRENT ASSETS, THESE INCLUDE FIXED ASSETS SUCH AS PROPERTY, PLANT, AND EQUIPMENT, AS WELL AS INTANGIBLE ASSETS LIKE PATENTS AND TRADEMARKS.

THE ACCURATE REPORTING OF ASSETS IS ESSENTIAL FOR EVALUATING A COMPANY'S PERFORMANCE AND FINANCIAL STABILITY. ANALYSTS OFTEN USE VARIOUS FINANCIAL RATIOS THAT CONSIDER ASSET VALUES, SUCH AS THE CURRENT RATIO AND RETURN ON ASSETS, TO ASSESS OPERATIONAL EFFICIENCY AND LIQUIDITY.
