THE BETTER BUSINESS BUREAU (BBB) WAS FOUNDED IN 1912 WITH THE MISSION TO PROMOTE TRUST BETWEEN BUSINESSES AND CONSUMERS. IT OPERATES AS A FEDERATION OF LOCAL BBBs LOCATED ACROSS NORTH AMERICA. THE BBB'S PRIMARY FUNCTION IS TO PROVIDE CONSUMERS WITH INFORMATION ABOUT BUSINESSES, INCLUDING THEIR RELIABILITY, QUALITY OF SERVICE, AND COMPLAINT HISTORY. THIS ORGANIZATION GATHERS DATA FROM VARIOUS SOURCES, INCLUDING CUSTOMER REVIEWS, BUSINESS PRACTICES, AND COMPLAINT RESOLUTIONS, TO COMPILE COMPREHENSIVE REPORTS ON BUSINESSES.

INFORMATION DISSEMINATION

ONE OF THE PRIMARY ECONOMIC FUNCTIONS OF THE BBB IS TO DISSEMINATE INFORMATION REGARDING BUSINESSES. THIS

INCLUDES:

- BUSINESS RATINGS BASED ON CUSTOMER FEEDBACK AND COMPLAINTS.
- ACCREDITATION STATUS THAT REFLECTS ADHERENCE TO THE BBB'S STANDARDS.
- ALERTS ABOUT SCAMS OR UNETHICAL BUSINESS PRACTICES.

BY PROVIDING THIS INFORMATION, THE BBB EMPOWERS CONSUMERS TO MAKE INFORMED CHOICES, WHICH CAN LEAD TO BETTER MARKET OUTCOMES. INFORMED CONSUMERS ARE MORE LIKELY TO CHOOSE REPUTABLE BUSINESSES, PROMOTING HEALTHY COMPETITION AND DISCOURAGING UNETHICAL PRACTICES.

CRITERIA FOR ACCREDITATION

TO BE ACCREDITED BY THE BBB, BUSINESSES MUST MEET THE FOLLOWING CRITERIA:

- COMMITMENT TO MAKE A GOOD FAITH EFFORT TO RESOLVE CONSUMER COMPLAINTS.
- MAINTAIN A POSITIVE TRACK RECORD IN THE MARKETPLACE.
- ADHERE TO THE BBB CODE OF BUSINESS PRACTICES.
- PROVIDE TRUTHFUL AND TRANSPARENT ADVERTISING.

ACCREDITED BUSINESSES ARE ASSIGNED A RATING FROM A+ TO F BASED ON THEIR PERFORMANCE AND HISTORY. THIS RATING SYSTEM PLAYS A PIVOTAL ROLE IN CONSUMER DECISION-MAKING, AS MANY CONSUMERS RELY ON THESE RATINGS TO GAUGE THE RELIABILITY OF A BUSINESS.

THE ECONOMIC IMPLICATIONS OF BBB RATINGS
