KEYNESIANS BELIEVE THAT DURING PERIODS OF LOW DEMAND, GOVERNMENT SPENDING CAN STIMULATE ECONOMIC GROWTH AND REDUCE UNEMPLOYMENT.

MONETARISM

MONETARISM, POPULARIZED BY ECONOMIST MILTON FRIEDMAN, POSITS THAT THE MONEY SUPPLY IS THE PRIMARY DRIVER OF ECONOMIC ACTIVITY. MONETARISTS ARGUE THAT CONTROLLING INFLATION REQUIRES CAREFUL MANAGEMENT OF THE MONEY SUPPLY, OFTEN ADVOCATING FOR RULES-BASED MONETARY POLICY.

THE ROLE OF GOVERNMENT IN ECONOMICS
