UNDERSTANDING ECONOMICS: A DEFINITION

KEY CONCEPTS IN ECONOMICS

THIS SCARCITY NECESSITATES TRADE-OFFS, LEADING TO THE CONCEPT OF OPPORTUNITY COST, WHICH IS THE VALUE OF THE NEXT BEST ALTERNATIVE THAT IS FOREGONE WHEN MAKING A CHOICE. UNDERSTANDING THESE CONCEPTS IS ESSENTIAL FOR MAKING INFORMED ECONOMIC DECISIONS.

SUPPLY AND DEMAND

SUPPLY AND DEMAND ARE THE CORNERSTONES OF MARKET ECONOMICS. THE LAW OF DEMAND STATES THAT, ALL ELSE BEING EQUAL, AS THE PRICE OF A GOOD DECREASES, THE QUANTITY DEMANDED INCREASES. CONVERSELY, THE LAW OF SUPPLY POSITS THAT AS THE PRICE OF A GOOD INCREASES, THE QUANTITY SUPPLIED ALSO INCREASES. THE INTERACTION OF SUPPLY AND DEMAND DETERMINES MARKET PRICES AND ALLOCATION OF RESOURCES.

TYPES OF ECONOMICS

ECONOMICS CAN BE BROADLY DIVIDED INTO SEVERAL SUBFIELDS, EACH FOCUSING ON DIFFERENT ASPECTS OF ECONOMIC ACTIVITY. THE MAIN TYPES INCLUDE CLASSICAL ECONOMICS, KEYNESIAN ECONOMICS, AND BEHAVIORAL ECONOMICS.

CLASSICAL ECONOMICS

CLASSICAL ECONOMICS, WHICH EMERGED IN THE LATE 18TH CENTURY, EMPHASIZES THE IMPORTANCE OF FREE MARKETS AND THE IDEA THAT MARKETS ARE SELF-REGULATING. KEYNESIAN ECONOMICS

IN CONTRAST, KEYNESIAN ECONOMICS, DEVELOPED BY JOHN MAYNARD KEYNES DURING THE GREAT DEPRESSION, ARGUES THAT ACTIVE GOVERNMENT INTERVENTION IS NECESSARY TO MANAGE ECONOMIC CYCLES. KEYNESIANS BELIEVE THAT GOVERNMENT SPENDING CAN HELP STIMULATE DEMAND DURING ECONOMIC DOWNTURNS, THUS PROMOTING RECOVERY.

BEHAVIORAL ECONOMICS

BEHAVIORAL ECONOMICS INTEGRATES INSIGHTS FROM PSYCHOLOGY WITH ECONOMIC THEORY, CHALLENGING THE TRADITIONAL NOTION OF RATIONAL DECISION-MAKING. THIS FIELD EXPLORES HOW PSYCHOLOGICAL FACTORS INFLUENCE ECONOMIC BEHAVIOR, LEADING TO ANOMALIES IN MARKET OUTCOMES.

IMPORTANCE OF ECONOMICS IN SOCIETY
