STRUCTURE AND FORMAT OF THE SEMINARS

THE SEMINARS ARE OFTEN ORGANIZED BY VARIOUS DEPARTMENTS AND RESEARCH CENTERS WITHIN COLUMBIA UNIVERSITY, EACH FOCUSING ON DIFFERENT ASPECTS OF ECONOMICS. THIS DIVERSITY IN ORGANIZATION ALLOWS FOR A RICH VARIETY OF TOPICS AND PERSPECTIVES TO BE DISCUSSED.

TYPES OF SEMINARS
