UNDERSTANDING THE CONCEPT OF SUBSTITUTES

THEY IMPACT HOW CONSUMERS ALLOCATE THEIR BUDGETS AND HOW BUSINESSES STRATEGIZE PRICING AND PRODUCT OFFERINGS. IMPERFECT SUBSTITUTES

IMPERFECT SUBSTITUTES, ON THE OTHER HAND, ARE GOODS THAT SATISFY SIMILAR NEEDS BUT ARE NOT IDENTICAL. THE DIFFERENCES IN QUALITY, FEATURES, OR BRAND LOYALTY INFLUENCE CONSUMER CHOICE. FOR INSTANCE, TEA AND COFFEE ARE IMPERFECT SUBSTITUTES; WHILE BOTH PROVIDE CAFFEINE AND CAN BE CONSUMED FOR SIMILAR PURPOSES, THEY OFFER DISTINCT FLAVORS AND EXPERIENCES.

FACTORS INFLUENCING SUBSTITUTION

SEVERAL FACTORS INFLUENCE THE DEGREE TO WHICH CONSUMERS WILL SUBSTITUTE ONE GOOD FOR ANOTHER. UNDERSTANDING THESE FACTORS IS ESSENTIAL FOR BUSINESSES AND ECONOMISTS ALIKE. KEY FACTORS INCLUDE:
