ULTIMATELY, A BALANCED APPROACH THAT INCORPORATES ELEMENTS FROM BOTH DEMAND SIDE AND SUPPLY SIDE ECONOMICS MAY PROVIDE THE MOST COMPREHENSIVE STRATEGY FOR FOSTERING SUSTAINABLE ECONOMIC GROWTH. POLICYMAKERS CAN DRAW ON THE STRENGTHS OF EACH THEORY TO CREATE ROBUST ECONOMIC POLICIES THAT ADDRESS THE COMPLEXITIES OF MODERN ECONOMIES.
