WHAT IS ECONOMICS?

RESOURCES EFFICIENTLY IN A MARKET ECONOMY.

OPPORTUNITY COST

OPPORTUNITY COST REFERS TO THE VALUE OF THE NEXT BEST ALTERNATIVE THAT IS FORGONE WHEN MAKING A DECISION. IT HIGHLIGHTS THE TRADE-OFFS INVOLVED IN ECONOMIC CHOICES. FOR EXAMPLE, IF A STUDENT SPENDS TIME STUDYING FOR A TEST INSTEAD OF WORKING A PART-TIME JOB, THE OPPORTUNITY COST IS THE WAGES THEY COULD HAVE EARNED DURING THAT TIME.

INCENTIVES

INCENTIVES ARE FACTORS THAT MOTIVATE INDIVIDUALS OR BUSINESSES TO ACT IN A CERTAIN WAY. ECONOMIC AGENTS RESPOND TO INCENTIVES, WHICH CAN BE FINANCIAL OR NON-FINANCIAL. FOR EXAMPLE, A TAX BREAK FOR ELECTRIC VEHICLE PURCHASES SERVES AS A FINANCIAL INCENTIVE TO ENCOURAGE CONSUMERS TO BUY ECO-FRIENDLY CARS.

TYPES OF ECONOMIC SYSTEMS

ECONOMIES CAN BE CATEGORIZED INTO VARIOUS SYSTEMS BASED ON HOW THEY MANAGE RESOURCES AND DISTRIBUTE GOODS. THE MOST COMMON TYPES INCLUDE:

MICROECONOMICS VS. MACROECONOMICS

MICROECONOMICS

THE ROLE OF GOVERNMENT IN ECONOMICS

REAL-WORLD APPLICATIONS OF ECONOMIC CONCEPTS
