UNDERSTANDING ECONOMICS AS A SOCIAL SCIENCE

BRANCHES OF ECONOMICS AND THEIR SOCIAL IMPLICATIONS

- **LABOR ECONOMICS:** ANALYZES LABOR MARKETS, EMPLOYMENT TRENDS, AND WAGE DETERMINATION.

THE IMPACT OF ECONOMIC THEORIES ON SOCIETY
