UNDERSTANDING SUPPLY AND DEMAND

ONE OF THE FOUNDATIONAL CONCEPTS IN ECONOMICS IS THE RELATIONSHIP BETWEEN SUPPLY AND DEMAND. THE LAW OF DEMAND STATES THAT, ALL ELSE BEING EQUAL, AS THE PRICE OF A GOOD DECREASES, THE QUANTITY DEMANDED INCREASES, AND VICE VERSA. CONVERSELY, THE LAW OF SUPPLY INDICATES THAT AS THE PRICE OF A GOOD INCREASES, THE QUANTITY SUPPLIED ALSO INCREASES. UNDERSTANDING THESE LAWS IS CRUCIAL FOR ANALYZING HOW MARKETS FUNCTION.

KEY FACTORS THAT CAN SHIFT THE SUPPLY AND DEMAND CURVES INCLUDE:

- **CONSUMER PREFERENCES:** CHANGES IN TASTES CAN INCREASE OR DECREASE DEMAND FOR CERTAIN PRODUCTS.
- **INCOME LEVELS:** AN INCREASE IN CONSUMER INCOME GENERALLY LEADS TO AN INCREASE IN DEMAND.

MARKET STRUCTURES

OLIGOPOLY CONSISTS OF A FEW LARGE FIRMS THAT DOMINATE THE MARKET. THESE FIRMS ARE INTERDEPENDENT, MEANING THE ACTIONS OF ONE FIRM CAN SIGNIFICANTLY IMPACT OTHERS.

MONOPOLY OCCURS WHEN A SINGLE FIRM CONTROLS THE ENTIRE MARKET FOR A PRODUCT OR SERVICE, LEADING TO HIGHER PRICES AND LESS CONSUMER CHOICE.
