AND EQUITY.

- **RAWLSIAN JUSTICE:** THIS THEORY ADVOCATES FOR POLICIES THAT MAXIMIZE THE WELFARE OF THE LEAST ADVANTAGED, EMPHASIZING EQUITY OVER EFFICIENCY. IT CHALLENGES TRADITIONAL EFFICIENCY METRICS BY PRIORITIZING FAIRNESS.

TRADE-OFFS BETWEEN EQUITY AND EFFICIENCY

THE TRADE-OFFS BETWEEN EQUITY AND EFFICIENCY MANIFEST IN VARIOUS WAYS, PARTICULARLY IN ECONOMIC POLICY DECISIONS.
