UNDERSTANDING THE ORIGINS OF "VODOO ECONOMICS"

THE TERM "VODOO ECONOMICS" WAS POPULARIZED DURING THE 1980 PRESIDENTIAL CAMPAIGN BY THEN-PRESIDENTIAL CANDIDATE GEORGE H.W. BUSH. IT WAS USED TO CRITICIZE THE ECONOMIC POLICIES PROPOSED BY RONALD REAGAN, PARTICULARLY THE IDEA OF SUPPLY-SIDE ECONOMICS, WHICH SUGGESTED THAT TAX CUTS AND DEREGULATION WOULD LEAD TO ECONOMIC GROWTH. CRITICS ARGUED THAT THESE IDEAS WERE UNREALISTIC AND POTENTIALLY HARMFUL, COINING THE TERM TO SUGGEST THAT SUCH ECONOMIC THEORIES WERE AKIN TO MAGIC OR WITCHCRAFT, LACKING GROUNDING IN REALITY.

VODOO ECONOMICS IMPLIES THAT THE PROPOSED BENEFITS OF SUCH POLICIES ARE BASED MORE ON WISFUL THINKING THAN ON EMPIRICAL EVIDENCE. THE PHRASE HAS SINCE BEEN ADOPTED IN VARIOUS CONTEXTS TO CRITIQUE ECONOMIC POLICIES THAT RELY ON OVERLY OPTIMISTIC PROJECTIONS WITHOUT SUFFICIENT DATA OR ANALYSIS. THIS CRITICISM RESONATES WITHIN BOTH POLITICAL AND ACADEMIC SPHERES, MAKING IT A RELEVANT TOPIC IN DISCUSSIONS ABOUT FISCAL RESPONSIBILITY AND ECONOMIC THEORY.

THE HISTORICAL CONTEXT OF VODOO ECONOMICS

THE CONTEXT SURROUNDING "VODOO ECONOMICS" INCLUDES SIGNIFICANT EVENTS IN AMERICAN ECONOMIC HISTORY, INCLUDING THE RECESSION OF THE EARLY 1980S.
