STANDARDIZED TEST SCORES

- **PREPARE FOR INTERVIEWS:** PRACTICE DISCUSSING YOUR RESEARCH INTERESTS AND FUTURE GOALS, AS INTERVIEWS CAN PLAY A CRITICAL ROLE IN THE SELECTION PROCESS.
- **APPLY TO MULTIPLE PROGRAMS:** INCREASE YOUR CHANCES OF ACCEPTANCE BY APPLYING TO SEVERAL FULLY FUNDED PROGRAMS THAT ALIGN WITH YOUR RESEARCH AND CAREER GOALS.

POTENTIAL CAREER PATHS AFTER A PhD IN ECONOMICS
