CURRICULUM AND COURSE STRUCTURE

ADMISSION REQUIREMENTS

- LETTERS OF RECOMMENDATION (TYPICALLY THREE)
- STATEMENT OF PURPOSE OUTLINING RESEARCH INTERESTS AND CAREER GOALS
- GRE SCORES (THOUGH SOME PROGRAMS MAY WAIVE THIS REQUIREMENT)

IT IS ESSENTIAL FOR APPLICANTS TO HIGHLIGHT THEIR ACADEMIC ACHIEVEMENTS AND ANY RELEVANT RESEARCH EXPERIENCE IN THEIR STATEMENT OF PURPOSE. THE ADMISSIONS COMMITTEE EVALUATES CANDIDATES HOLISTICALLY, CONSIDERING BOTH ACADEMIC RECORDS AND POTENTIAL FOR RESEARCH.

CAREER OPPORTUNITIES FOR GRADUATES
