A: BASE EROSION AND PROFIT SHIFTING (BEPS) REFERS TO TAX AVOIDANCE STRATEGIES THAT MULTINATIONAL COMPANIES USE TO SHIFT PROFITS FROM HIGH-TAX JURISDICTIONS TO LOW-TAX JURISDICTIONS. THIS PRACTICE CAN UNDERMINE NATIONAL TAX BASES, PROMPTING GOVERNMENTS TO COLLABORATE INTERNATIONALLY TO DEVELOP EFFECTIVE TAX POLICIES.
