UNDERSTANDING THE OBJECTIVES OF A LESSON PLAN

THIS OBJECTIVE NOT ONLY SPECIFIES WHAT STUDENTS NEED TO LEARN BUT ALSO INDICATES HOW THEIR UNDERSTANDING CAN BE ASSESSED.

COMPONENTS OF AN EFFECTIVE ECONOMICS LESSON PLAN
