FINANCIAL ECONOMICS

STUDENTS LEARN ABOUT FINANCIAL MARKETS, INVESTMENT STRATEGIES, AND RISK MANAGEMENT, PREPARING THEM FOR CAREERS IN FINANCE AND BANKING.

ENVIRONMENTAL ECONOMICS

THIS AREA EXPLORES THE ECONOMIC IMPACTS OF ENVIRONMENTAL POLICIES, SUSTAINABILITY, AND RESOURCE MANAGEMENT, APPEALING TO THOSE INTERESTED IN ECOLOGICAL ISSUES.

LABOR ECONOMICS

FOCUSING ON LABOR MARKETS, WAGES, AND EMPLOYMENT POLICIES, THIS SPECIALIZATION IS IDEAL FOR THOSE LOOKING TO

WORK IN HUMAN RESOURCES OR PUBLIC POLICY.

CAREER OPPORTUNITIES

A MASTER'S IN ECONOMICS OPENS THE DOOR TO A WIDE RANGE OF CAREER OPPORTUNITIES ACROSS VARIOUS SECTORS. GRADUATES CAN PURSUE ROLES IN GOVERNMENT, PRIVATE INDUSTRY, NON-PROFIT ORGANIZATIONS, AND ACADEMIA. SOME COMMON POSITIONS INCLUDE:

- ECONOMIC ANALYST
- FINANCIAL CONSULTANT
- POLICY ADVISOR
- MARKET RESEARCH ANALYST
- DATA SCIENTIST
