- **MARKET STRUCTURES:** MICROECONOMICS ANALYZES VARIOUS MARKET STRUCTURES, INCLUDING PERFECT COMPETITION, MONOPOLISTIC COMPETITION, OLIGOPOLY, AND MONOPOLY, EACH WITH DISTINCT CHARACTERISTICS AND IMPLICATIONS FOR PRICING AND OUTPUT DECISIONS.
- **UTILITY MAXIMIZATION:** CONSUMERS AIM TO MAXIMIZE THEIR SATISFACTION OR UTILITY FROM GOODS AND SERVICES WITHIN THEIR BUDGET CONSTRAINTS.
- **PRODUCTION AND COSTS:** FIRMS MAKE PRODUCTION DECISIONS BASED ON COST STRUCTURES, TECHNOLOGY, AND THE

GOAL OF PROFIT MAXIMIZATION.

UNDERSTANDING MACROECONOMICS

MACROECONOMICS, ON THE OTHER HAND, LOOKS AT THE ECONOMY AS A WHOLE. IT FOCUSES ON AGGREGATE INDICATORS SUCH AS NATIONAL INCOME, TOTAL EMPLOYMENT, INFLATION RATES, AND OVERALL ECONOMIC GROWTH. MACROECONOMIC ANALYSIS IS ESSENTIAL FOR UNDERSTANDING HOW ECONOMIES FUNCTION ON A LARGER SCALE AND HOW VARIOUS POLICIES CAN INFLUENCE ECONOMIC CONDITIONS.

KEY CONCEPTS IN MACROECONOMICS

KEY DIFFERENCES BETWEEN MICRO AND MACRO
