- **SCARCITY:** MONEY SHOULD BE LIMITED IN SUPPLY TO MAINTAIN ITS VALUE.

THESE CHARACTERISTICS MAKE MONEY AN EFFECTIVE MEDIUM OF EXCHANGE AND CONTRIBUTE TO ITS OVERALL EFFICIENCY WITHIN THE ECONOMY. THE BETTER MONEY FULFILLS THESE CHARACTERISTICS, THE MORE EFFECTIVE IT IS IN FACILITATING ECONOMIC TRANSACTIONS.

TYPES OF MONEY

BANK MONEY

BANK MONEY REFERS TO MONEY CREATED THROUGH THE BANKING SYSTEM, PRIMARILY IN THE FORM OF DEPOSITS. IT INCLUDES CHECKS, DEBIT CARDS, AND ELECTRONIC TRANSFERS. BANK MONEY IS WIDELY USED IN TODAY'S ECONOMY AND FACILITATES DIGITAL TRANSACTIONS.

THE ROLE OF MONEY IN THE ECONOMY

MONEY AND BANKING
