UNDERSTANDING NORMATIVE ECONOMICS

AT ITS CORE, NORMATIVE ECONOMICS ENGAGES WITH THE IMPLICATIONS OF ECONOMIC DECISIONS AND POLICIES, EVALUATING THEIR EFFECTS ON SOCIETAL WELFARE. THIS ASPECT IS VITAL IN SHAPING THE ECONOMIC LANDSCAPE, AS IT ALLOWS FOR DISCUSSIONS ABOUT EQUITY, EFFICIENCY, AND JUSTICE WITHIN THE FRAMEWORK OF ECONOMIC THEORY. THIS DISTINCTION IS CRUCIAL BECAUSE IT HIGHLIGHTS THE DIFFERENT OBJECTIVES AND METHODOLOGIES EMPLOYED IN ECONOMIC ANALYSIS. POSITIVE ECONOMICS PROVIDES THE DATA AND EVIDENCE NECESSARY TO INFORM DECISIONS, WHILE NORMATIVE ECONOMICS EVALUATES THE DESIRABILITY OF THOSE DECISIONS BASED ON SOCIETAL VALUES.

APPLICATIONS OF NORMATIVE ECONOMICS
