HISTORY OF THE PETERSON INSTITUTE

THE PETERSON INSTITUTE FOR INTERNATIONAL ECONOMICS, OFTEN REFERRED TO AS THE PIIE, WAS FOUNDED BY ECONOMIST ADAM S. P. PETERSON IN 1981. INITIALLY NAMED THE INSTITUTE FOR INTERNATIONAL ECONOMICS, IT WAS ESTABLISHED IN RESPONSE TO THE GROWING NEED FOR INFORMED ANALYSIS ON INTERNATIONAL ECONOMIC ISSUES. OVER THE YEARS, THE INSTITUTE HAS EVOLVED INTO ONE OF THE MOST RESPECTED THINK TANKS IN THE FIELD OF INTERNATIONAL ECONOMICS.

IN 2001, THE INSTITUTE WAS RENAMED TO HONOR ITS FOUNDER, REFLECTING ITS COMMITMENT TO HIGH-QUALITY RESEARCH AND POLICY RECOMMENDATIONS. TRADE POLICY

MACROECONOMIC POLICY
