ABILITIES AND POTENTIAL FOR RESEARCH.

- **STATEMENT OF PURPOSE:** A DETAILED ESSAY DESCRIBING THE APPLICANT'S ACADEMIC INTERESTS, RESEARCH GOALS, AND REASONS FOR CHOOSING DUKE.
- **GRE SCORES:** WHILE SOME PROGRAMS HAVE MADE GRE SUBMISSION OPTIONAL, A STRONG SCORE CAN ENHANCE AN APPLICATION.

AFTER SUBMISSION, APPLICATIONS ARE REVIEWED HOLISTICALLY, CONSIDERING ALL ASPECTS OF THE CANDIDATE'S BACKGROUND AND POTENTIAL CONTRIBUTIONS TO THE PROGRAM.

CAREER PROSPECTS
