POLICYMAKERS OFTEN RELY ON EMPIRICAL DATA AND ECONOMIC MODELS TO EVALUATE THE POTENTIAL IMPACT OF THEIR PROPOSALS, BALANCING ECONOMIC EFFICIENCY WITH SOCIAL EQUITY.

THUS, THE POLITICAL CONTEXT IS CRUCIAL IN DETERMINING THE FEASIBILITY AND SUCCESS OF ANY POLICY INITIATIVE.

ECONOMIC THEORIES INFLUENCING POLITICS

KEY ECONOMIC THEORIES

THE ROLE OF POLICY IN ECONOMIC CRISES
