SEEK STRONG RECOMMENDATIONS

CHOOSE RECOMMENDERS WHO KNOW YOU WELL AND CAN SPEAK TO YOUR STRENGTHS AND POTENTIAL. PROVIDE THEM WITH INFORMATION ABOUT THE SCHOLARSHIP AND YOUR GOALS TO HELP THEM WRITE A COMPELLING LETTER.

REVIEW AND EDIT

BEFORE SUBMITTING, REVIEW YOUR APPLICATION FOR ANY ERRORS OR OMISSIONS. PROOFREADING CAN HELP ENSURE THAT YOUR MATERIALS ARE POLISHED AND PROFESSIONAL.
