BY VISUALIZING THESE INTERACTIONS, THE CIRCULAR FLOW MODEL HELPS ILLUSTRATE CONCEPTS SUCH AS PRODUCTION, CONSUMPTION, AND INCOME GENERATION WITHIN AN ECONOMY. GOODS AND SERVICES

FLOW OF MONEY

IN RETURN, FIRMS PROVIDE INCOME TO HOUSEHOLDS IN THE FORM OF WAGES AND OTHER PAYMENTS FOR THE FACTORS OF PRODUCTION. THIS DUAL FLOW CREATES A CONTINUOUS LOOP THAT SUSTAINS ECONOMIC ACTIVITY.

INTERACTIONS BETWEEN SECTORS

LACK OF CONSIDERATION FOR ECONOMIC INEQUALITY

THE CIRCULAR FLOW MODEL DOES NOT ADDRESS ISSUES OF INCOME DISTRIBUTION AND ECONOMIC INEQUALITY. IT ASSUMES THAT ALL HOUSEHOLDS HAVE EQUAL ACCESS TO INCOME AND RESOURCES, WHICH IS RARELY THE CASE IN PRACTICE.
