CHANGES IN INTEREST RATES CAN AFFECT BORROWING COSTS AND CONSUMER SPENDING, LEADING TO FLUCTUATIONS IN THE STOCK MARKET. FOR EXAMPLE, LOWERING INTEREST RATES CAN ENCOURAGE BORROWING AND INVESTMENT, POTENTIALLY BOOSTING STOCK PRICES.

FISCAL POLICY
