INTRODUCTION TO TRICKLE DOWN ECONOMICS

TRICKLE DOWN ECONOMICS IS A TERM OFTEN USED TO DESCRIBE POLICIES THAT FAVOR THE WEALTHY OR BUSINESSES WITH THE EXPECTATION THAT THESE ADVANTAGES WILL EVENTUALLY BENEFIT THE BROADER POPULATION. THE CORE PRINCIPLE IS THAT ECONOMIC GROWTH IS MOST EFFECTIVELY STIMULATED BY ALLOWING THOSE AT THE TOP OF THE ECONOMIC LADDER TO RETAIN MORE OF THEIR INCOME. PROPONENTS ARGUE THAT WEALTHY INDIVIDUALS ARE MORE LIKELY TO INVEST THEIR RESOURCES IN WAYS THAT GENERATE JOBS AND STIMULATE CONSUMER SPENDING. CRITICS, HOWEVER, CONTEND THAT THIS APPROACH LEADS TO INCREASED INCOME INEQUALITY AND FAILS TO DELIVER PROMISED BENEFITS TO LOWER-INCOME INDIVIDUALS.

HISTORICAL BACKGROUND

THE ORIGINS OF TRICKLE DOWN ECONOMICS CAN BE TRACED BACK TO SUPPLY-SIDE ECONOMICS, WHICH EMERGED IN THE 1970s AND GAINED TRACTION IN THE 1980s. ITS FOUNDATIONAL BELIEF IS THAT LOWERING TAXES ON BUSINESSES AND THE WEALTHY WILL ENCOURAGE INVESTMENT IN THE ECONOMY. THE 1980s AND REAGANOMICS

DURING THE 1980s, THE U.S. GOVERNMENT ADOPTED A SERIES OF POLICIES REFLECTIVE OF TRICKLE DOWN ECONOMICS, COMMONLY REFERRED TO AS REAGANOMICS. THESE INCLUDED SIGNIFICANT TAX CUTS FOR INDIVIDUALS AND CORPORATIONS, DEREGULATION, AND REDUCTIONS IN GOVERNMENT SPENDING. THE RATIONALE WAS THAT BY ALLOWING WEALTHIER INDIVIDUALS

AND CORPORATIONS TO KEEP MORE OF THEIR EARNINGS, THEY WOULD REINVEST IN THE ECONOMY, LEADING TO JOB CREATION AND OVERALL GROWTH.

PREVIOUS ECONOMIC THEORIES

BEFORE THE EMERGENCE OF TRICKLE DOWN ECONOMICS, OTHER ECONOMIC THEORIES ALSO INFLUENCED U.S. POLICIES. KEYNESIAN ECONOMICS, FOR EXAMPLE, EMPHASIZED THE ROLE OF GOVERNMENT SPENDING IN STIMULATING DEMAND AND DRIVING ECONOMIC GROWTH. THE SHIFT TOWARDS TRICKLE DOWN THINKING MARKED A DEPARTURE FROM THESE PRINCIPLES, FOCUSING INSTEAD ON SUPPLY-SIDE SOLUTIONS. WHILE PROPONENTS BELIEVE IT FOSTERS INNOVATION AND ECONOMIC EXPANSION, CRITICS ARGUE THAT IT CAN LEAD TO MARKET ABUSES AND FINANCIAL CRISES. THE DEREGULATION OF THE BANKING INDUSTRY IN THE LATE 1990S, FOR INSTANCE, HAS BEEN LINKED TO THE 2008 FINANCIAL CRISIS, RAISING QUESTIONS ABOUT THE LONG-TERM SUSTAINABILITY OF SUCH POLICIES.

ARGUMENTS FOR TRICKLE DOWN ECONOMICS

SUPPORTERS OF TRICKLE DOWN ECONOMICS PRESENT SEVERAL ARGUMENTS IN FAVOR OF ITS PRINCIPLES. THEY CLAIM THAT:

- TAX CUTS STIMULATE INVESTMENT AND ECONOMIC GROWTH.

ADVOCATES HIGHLIGHT INSTANCES WHERE TAX CUTS HAVE COINCIDED WITH PERIODS OF ECONOMIC GROWTH, USING THESE EXAMPLES TO ARGUE THAT TRICKLE DOWN POLICIES EFFECTIVELY STIMULATE THE ECONOMY.

ARGUMENTS AGAINST TRICKLE DOWN ECONOMICS

CONVERSELY, CRITICS OF TRICKLE DOWN ECONOMICS ARGUE THAT IT EXACERBATES INCOME INEQUALITY AND FAILS TO DELIVER ON ITS PROMISES. THEY ASSERT THAT:

IMPACT ON SOCIETY AND ECONOMY
